#### SUMMARY

Universe Knitting Garments was surveyed for fire safety on 11/14/2015 by Jensen Hughes. This summary identifies the major deficiencies that were identified during the inspection.

The purpose of this survey was to identify significant fire safety issues and to provide recommendations for remediation based on applicable standards specified by the Accord. The scope of this initial fire safety inspection was limited to the review and identification of major fire safety issues. The inspection did not include identification of minor deficiencies, which will be further addressed as part of follow-up inspections.

Table 1 summarizes the major fire safety issues identified during the inspection. Recommendations have been provided to address each issue.

An implementation schedule shall be developed by the factory to remediate each of the findings. The specific timing of improvements, including any requested extensions due to design / installation constraints, shall be submitted to the Accord for approval.



Provide proper ventilation and consult with a qualified engineer.	Within 3 months



F-2	Egress	Egress doors / gates with locking features are provided at building	Remove locking features from all egress doors / gates.	Immediately
		exits, along egress routes and exit discharge.	If locks are required for security reasons, utilize special door locking features complying with ACCORD




### F-3 Egress

Collapsible gates / sliding doors are provided at building exits, along egress routes and exit discharge.

Replace all gates / sliding doors along the means of egress with side-hinged, swinging egress doors in accordance with ACCORD standard 6.8.1.

Within 1 month

Fire Protection The fire alarm system is antiquated, not a listed system and does not provide alarm and notification features consistent with acceptable standards.

Replace the fire alarm system with a new, listed automatic fire alarm system in accordance with NFPA 72 and ACCORD standards.

Design within 4 months, install within 9 months
